

# A formal consultation about our proposal to increase the number of special school places at Brookfield School, Fouldrey Avenue, Poulton-le-Fylde, Lancashire, FY6 7HE through the expansion of the school site

# Nov 2024

This is a formal consultation about making a prescribed alteration to a school in accordance with The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2013.

Lancashire County Council PO Box 100, County Hall, Preston, PR1 0LD We are seeking your views about our proposal to expand Brookfield School and whether you think this is a good idea. We are proposing to increase the number of special school places by 45, by creating additional classroom space on the school site.

We want to assure you that we will give careful consideration to all your comments and opinions.

We have used the feedback that was given during the informal consultation, conducted between 4 November and 22 November 2024, to develop our plans about increasing the number of school places at Brookfield School. This formal consultation is a legal requirement that we need to do in order to make a change like this to the school.

#### What are we planning to do?

Brookfield School is a special school for pupils agreed 11-16 with social, emotional and mental health needs. The proposal is to expand the school, increasing the number of places by 45.

#### Why are we doing this?

All special schools in Lancashire are over-subscribed and there continues to be an increase in the need for special school places throughout the County.

Brookfield School is a 'Good' school (Ofsted).

#### How will we do this?

By creating additional places on the Brookfield School site. Children and young people already on the roll will still be able to attend the school and should not experience any change in class size because of the increase to approved numbers.

The school will receive additional funding from the Special Educational Needs high needs block to provide support for any additional pupils that join the school, in line with the funding for places at specialist schools. This means the school should not be financially disadvantaged by the proposed expansion.

### What have we done so far?

We have considered the options for increasing the number of special school places in the North of the county with the headteachers of the special schools in that area.

We have discussed this proposal with the headteacher and governors of Brookfield School.

An informal consultation took place between 4 November and 22 November 2024 when we asked for the views of families of children and young people attending the school, children and young people who may attend the school in the future, school staff and governors and other members of the local community. A public meeting was also held on 14 November 2024, where a representative from Lancashire County Council attended.

The written responses to the informal consultation were considered by the Executive Director for Education and Children's Services, in consultation with the Cabinet Member for Education and Skills after the end of the consultation period.

Of the eight responses received to the informal consultation, all 8 respondents strongly agreed with the proposal; comments included the demand for special school places in Lancashire is not being met, the dedication of staff and leadership at the school, the excellent provision, and the need for the appropriate level of funding should the expansion go ahead. Space has been identified for the additional classroom and the headteacher will ensure additional resources needed are available.

#### What will happen next?

Careful consideration will be given to all responses that are received on or before 20 December 2024.

These responses will be used to provide information to Lancashire County Council's Cabinet to help councillors decide whether to agree to the increase in school numbers.

#### Have your say
